ACCEPTANCE OF MINUTES OF May 20, 2020

On a motion by Margaret Vennochi the minutes of May 20, 2020, Staff Senate meeting was accepted.

### CHAIR'S COMMUNICATIONS

HR meetings – we met with HR twice over the last month. They informed us the broadband updates are still on schedule to be complete over the summer. We also discussed the return to work plan. They have two Q&A sessions today.

Title IX Listening Session – The Gender and Equality Center lead a staff listening session asking for input on the implementation of the new Title IX regulations. Thank you to all of you who were able to participate in such short notice.

Crystal, Justin, Melissa, and I met with President Harroz and VP Burrage yesterday. They informed us the PTO policy change is under review and will not be on the June Regent's agenda. Further, the FY21 budget is looking better than expected, if we can keep students on campus throughout the fall.

#### REPORTS FROM MEMBER GROUPS

Administrative Staff Council: President Patrick McClain reported that they did not meet.

**Hourly Employees Council:** President Tanya Miller Eager reported that they met last week, they had a lively and lengthy discussion about returning to campus. There are concerns about how employees are being notified when they are exposed to co-workers who test positive for Covid-19. The new overtime policy was brought up and they had a conversation about how that would impact staff on call and those who work special events. It was decided that they'd have continued conversations. They finished their meeting with an election update.

**Informational Staff Association:** President Cathy Yeaman reported that they had an update on the new overtime policy going into effect, Spring 2021. They held elections for the upcoming year. There are still seats available for VP (Chair-Elect), Activities Coordinator, 1 seat for Staff Senate 2019-2021 and, 1 seat for 2020-2022. They continued their discussion on the fundraiser for face masks, name, and updated the committee that Staff Initiatives is working on Bereavement Leave.

**Organizational Staff Council:** By email, President Shannon Overstreet reported that they discussed returning to campus and holding elections in September. Julia Rouse gave them an update on the hiring process with the hiring freeze in place. They also discussed rotating schedules for individuals who share an office or are in close quarters, such as those in cubicles.

## **Benefits Update**

- Three RFPs (dental, vision, and Medicare Advantage) were issued, evaluated, and finalist forwarded to senior leadership for consideration. Committee work was not completed in time for inclusion on the June Board of Regents agenda.
- Benefits also proposing a 3-tier medical premium contribution model and a change to the salary bands within the model. Additionally, the benefits team is proposing moving the Norman campus to the HSC medical plan design.
- OU medical plans continue to offer COVID-19 treatment coverage at no cost to the employee through June 30, 2020.
- Medical expenses are running under budget (87% in Norman). The decrease may be a result of medical facilities cancelling elective procedures.
